CC 134 MS. WENDY BRACKEN, NEWCASTLE RESIDENT, emailing the Clerk's Department, a copy of her delegation to Regional Council on June 29, 2011.

Ms. Bracken's delegation was regarding the Durham/York Residual Waste Environmental Assessment, the Certificate of Approval applications and the Durham/York Co-Owner's agreement for the Energy-from-Waste facility. She writes in regards to the Durham/York Co-Owners' agreement, "that York Region, in for 21.4% of the capital cost, this agreement gives them 50% control (Section 8), and they can add on at any time at their own discretion. That is not acceptable. There are no safeguards in this agreement for health. Given what you know, the facts that affect health and well being of Clarington and Durham residents, the facts about the current status of air shed at the site and the additional burden of the incinerator emissions which are documented in your own EA, if you adopt this Co-Owner's agreement with no medical opinion on the increased emissions, no safeguards built into your agreement, with no Medical Officers of Health sitting on the Management Committee, knowing what you do know and what has been brought to your attention over and over again about the present air quality, you would be basically throwing your own Durham residents under the bus. You have to get a written health opinion about this and you cannot proceed, nor give authority to proceed until you do." (Our File: D04-71)

DEBRA JEFFERSON, NEWCASTLE RESIDENT, emailing the Clerk's Department, correspondence dated May, 2011 from the Bowmanville Area Medical Association (representing 47 physicians who practice in Clarington), registering their concerns regarding the Certificate of Approval application for the proposed Durham-York waste incinerator. "It is ironic that the Ontario government is touting the health benefits to be achieved by the shutdown of coal-fired generating stations, while at the same time considering approval of this project. Garbage incineration, the waste management option with the greatest documented impact on air quality, will have both immediate and longterm effects on human health and the environment. Ultimately, it will be our most vulnerable populations – the developing fetus, young children, the elderly, and those with chronic cardiac and respiratory illnesses that face the greatest risks to their health, as a result of this proposed incinerator. We urge the Ministry of the Environment to DENY the Certificate of Approval, and instead recommend that Durham and York Regions adopt alternative, and progressive waste management strategies that do not include incineration."
